Double Jeopardy protections in the U.S. Constitution keep criminal defendants from facing prosecution more than once for the same offense (with a few exceptions). In law, protection against the use by the state of certain multiple forms of prosecution. In general, in countries observing the rule of double jeopardy, a person cannot be tried or punished again for an offense for which the person has already been tried or punished.
